

Purpose of ERO FDI Working group "Integration"

is the integration of Western, Central and Eastern European countries by the most actual dental topics such as dental prevention, education, liberal dental practice in Europe, quality in dentistry, dental team, relation between Universities and dental practitioners, aging population. The main principle of integration is taking the best experience from each ERO country for development dentistry in ERO FDI.



Shortly, Results of ERO WG Integration activities:

April 2011, Sofia – changed the name of the WG from Enlargement to Integration. New members of the WG

September 2011, Mexico – established a good relations with Eastern European countries:

Armenia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Turkmenistan, Ukraine

October 2011, Antalya - ERO FDI presentation of importance and benefit of being a member of ERO, importance of dental experience exchanges



April 2012, Prague – WG Integration members suggested to start ERO Integration from prevention and dental professional education in ERO countries

November 2012, Moscow - meeting of the Presidents of Eastern European dental associations and WG Integration members dedicated ERO collaboration, dental professional education and national preventive programs

- dental practices and quality control services provided by the NDAs, insurance systems in ERO countries
- National Program of dental prevention as a basis of national dental associations work

April 2013, Potsdam

The results of WG Integration meeting in Potsdam was adopted resolution by Plenary Session of the partnership between Ministry of Health and NDAs



Resolution from ERO WG Integration

Statement:

In order to facilitate to reach the goal of Optimal Oral Health for all people, the ERO-FDI WG "Integration" recommend strongly to the Minister of Health to work in close relationship with the National Dental Associations.

National Dental Associations should become involved in all political and legislative processes and decisions regarding matters of oral health and oral health care.

National Dental Associations should offer advice and support in relation to the planning of Oral health and related measures.

The partnership, Ministry of Health and National Dental Association will beneficial for the patients and the nation to reach Optimal Oral Health.
