The agenda of ERO WG Integration meeting in Irkutsk was dedicated to the continuing dental education according to the decision of following our work started in November 2013 in Moscow and regarding the modernization of dental education in Russia and Eastern European countries.

In the first section the WG member Michele Aerden, Past-President of FDI reported on New EU directives for the dental education. Hans Schrangl, the General Secretary of ERO FDI represented the dental education in Austria. The Chief Dental Officer of the Russian Ministry of Health Oleg Yanushevich who had to fly back to Moscow missioned Solomon Rabinovich to relate about the Russian dental education. Prof. Oleg Yanushevich together with the Vice-Minister of the Russian Ministry of Health Oleg Salagay arrived to Irkutsk especially for opening and supporting the ERO WG Integration meeting.

As hosts of the event who shared interest to the theme the representatives of Irkutsk State Medical University Prof. Andrey Scherbatykh, the Vice-Rector for studies of ISMU, Alexey Kalyagin, the Vice-Rector for clinical work and continuing education of ISMU, Tamara Krupskaya, the Vice-Rector for foreign affairs of ISMU, Arkadiy Vyazmin, the Dean of Dental Faculty and Tatyana Gaidarona, President of Irkutsk Dental Association have participated in this meeting.

The second section of ERO WG Integration meeting was dedicated to continuing dental education. Jurgen Fedderwitz reported about the continuing education in Germany, Hans Schrangl about the continuing dental education in Austria and Borislav Milanov about that of Bulgaria. Solomon Rabinovich as the spokesman of Oleg Yanushevich, Chief Dental Officer of the Ministry of Health of Russian Federation presented the pilot project of Russian Ministry of Health for continuing education.

WG Integration members without other participants of the meeting discussed of further WG Integration activity considering the recommendation of WG supervisor Hans Schrangl. On common agreement, WG members considered:

- to finalize the EU Manual for dental practice upon responses from the remain Eastern European countries to a questionnaire to New-Deli;
- as well as to continue the integration activity with prevention issue in mind over the other Eastern European countries;
- to continue educational theme organizing common meeting with ERO WG Continuing education;
- to include integration activity for dental science starting with Russia.

The President of Bulgarian dental association Borislav Milanov and Michele Aerden also suggested to involve Central European countries such as Balkan countries to the integration activity on these topics because of their actuality.

In conclusion, the ERO WG Integration meeting activity was to establish a good relationship between ERO and new ERO countries and to open the opportunity for information and experience exchange between NDAs leading to the mission of improvement of dental health care.
