Different questions have to be discussed, such as: Is there a need of binding rules for payment at all? Is there a dissent between liberal practice and fee schedules? How can we achieve a balance between liberal dental practice and external interests?

In order to achieve a summary in particular ERO-States we have started a survey with the headline "How free ore compulsive are dental fee schedules in the ERO-member states?

Hoping we can present first good answers in the coming Plenary Session in Prague!
