WG Integration

WG-chair Elena Ivanova is working eagerly since the Sofia Plenary session. The WG's task is to bring all eastern NDApresidents together in order to define needs and interactive work with the Organization. A congress has been organized with the Commonwealth International Association so far. More news on the WG's workflow are to be expected at September 14th.

WG Prevention

Chair: Denis Bourgeois

The Prevention WG has developed its work on the relationship between cardiovascular disease/stroke and periodontal disease in terms of a common risk factor approach and definition. The first step, a selective literature review, has been performed. As a result in a workshop in Geneva the basic elements for the realization of a questionnaire have been defined. The purpose is to elaborate ERO guidelines/recommendations for the dentist. This will be the final result after all data have been discussed in a specific consensus conference. The project integrates perfectly into FDI's Global Oral Health Initiative and will support actively FDI's Non-Communicable-Disease-Policy. The ERO-region can contribute significantly to a positive outcome. Denis Bourgeois will present the questionnaire in Mexico City.

WG Education

Chair: Alex Mersel

The WG has been active in realizing questionnaires and has presented an evaluation to be presented at the next Plenary session. Unfortunately, Prof. Mersel will not be able to be with us in Mexico City. On his behalf Prof. Paulo Melo will chair the WG.

WG Women in Dentistry

Chair: Vesna Barac-Furtinger

The WG is going on with its work in the identification of differences between man and women dental practice focussing mainly on deficient post-graduate education, inequality in specialisations and poor representation on decision-making levels. More news in terms of new tasks and conclusions will be delivered soon.

WG Quality in Dentistry

Chair: Roland L'Herron

The WG has had a workshop in Paris recently. The task is to "define quality of care and quality of care environment". A drafted questionnaire relates to education, a second part relates more specifically to quality tools and a third part completes the information on practice in the ERO membercountry. A presentation will be made in Mexico and results are to be expected by the end of the year.

WG Dental Team

Chair: Edoardo Cavallè

The WG met in Frankfurt recently and has investigated on the profile of the dental hygienist and the institution of other auxiliary human resources. There will be a presentation and a discussion at the upcoming Plenary session.
