On 20 November I have participated at the CED's general meeting in Brussels.

During the plenary session, the CED members elected Dr. Marco Landi (Italy) as new CED President for a three-year term. Dr. Hans Schrangl (Austria) and Dr. Piret Väli (Estonia) were elected as Directors and Dr. Alexander Tolmeijer (Netherlands) was reelected as Director. They join the current Directors Dr. Pirkko Grönroos (Finland), Dr. Roland L'Herron (France), Dr. Peter Engel (Germany) and Dr. Susie Sanderson (United Kingdom). I would like to congratulate Marco Landi for his election and wish him all the best and a constructive collaboration with ERO. At this point, I also thank Wolfgang Doneus for the great work he did as President of the CED during many years and for the good cooperation with ERO.

Since four of five ERO board members participated at CED meeting, we had our ERO board meeting the day after and treated current affairs:

 The ERO board noticed with satisfaction that the document concerning the profile of dental hygienists adopted in Tbilisi is very useful. The dentist's position has been clearly stated and it is a real advantage



since the European Union is now regulating this profession.

- The decision taken by FDI council on 21th of September 2015 (see minutes B.4 ERO Plenary session Bangkok) has been analyzed and the ERO board has decided to write a letter to FDI Council to ask them to reconsider this decision, which is likely to have negative consequences, because this situation undermines the common trust between our member organizations.
- Until now, we have very few candidates for the new WG « aging population ». Soon this problem will concern all our NDA's and it is important to anticipate the upcoming problems. This WG will not be a group of experts, but a discussion panel where we can share experiences and register what we have to do.
- For the other WG we have many projects under work and we hope to have final documents in Baku.
- The preparations regarding next plenary in Baku are in final elaboration and documents will be spread at the beginning of 2016.
- The ERO board has to be reelected during the next plenary session. Please prepare our future and present valuable candidates. Thank you in advance.

As invitee, I have participated at the French ADF congress in Paris. The organizers had decided to maintain this event despite the tragic assassinations of Friday 13th of November.
