At this Plenary Session the elections for the ERO Board were held.

Delegates gathered in Baku adopted "ERO accreditation guidelines for Continuing Dental Education Providers" and recommendations for national dental organizations to cooperate with dental faculties in the field of clinical guidelines and their use in dental practice as a supportive tool.



ERO-FDI plenary meeting in Baku

Participants discussed a wide range of issues related to dentistry in Europe, in particular the scope of professional tasks of dental hygienists – delegates unanimously reconfirmed that the principle "Delegation – yes, substitution – no" is fully valid and should be applied in all countries of the region.

FDI President, dr Patrick Hescot (former ERO President between 2007 – 2010), attended as guest and informed the delegates about the recent activities within the FDI (focusing on the implementation of the FDI Strategic Plan 2014-2017). Dr. Hescot also underlined the importance of deep cooperation between the FDI and its members - national dental organizations. He is of the opinion that personal attendance of the FDI President at regional and national dental assemblies is one of the methods to develop this cooperation.

Dr. Simona Dianiskova from Slovakia was confirmed as Chair of Working Group Relations between dental practitioners and Universities. Many thanks to the former Chair of this Group, prof. Nermin Yamalik, for the successful work and great commitment.

A new Working Group Aging Population was set up in order to collect experiences and information related to the issue of aging population. The goal is to work out a few guidelines or recommendations on how best to deal with this problem. The first meeting of the group is organized by dr. Philippe Rusca and will take place in Munich on 15 July.

ERO Board meeting in Warsaw

First meeting of the new ERO Board was held in Warsaw on 25 June.

The issues that were discussed included:

- allocation of competencies within the new ERO Board;
- current situation regarding ERO Working Groups;
- agenda of the next ERO Plenary Session;
- strengthening cooperation with FDI.

The Board took the following decisions:

- updating the lists of members of ERO working groups;
- gathering the plans of future activities of ERO working groups;
- submitting a draft statement on medical education in dentistry for adoption at the FDI General Assembly.

Kazakhstan – formation of National Committee

In May 2016 two dental associations in Kazakhstan finally signed a long awaited memorandum setting up the national Committee. We are looking forward to deepening cooperation with Kazakhstan and encourage colleagues from this country to actively engage in ERO activities.
