 All countries to secure a uniform application of professional law by introducing compulsory membership in dental chambers for all kind of legal entities offering dental services in the interest of patients.



It would be contradictory and harmful, if legal entities practicing dentistry, unlike self-employed and employed dentists, are not subject to professional regulations which serve in particular to protect patients. The compulsory membership only of the individual dentist, working in a legal entity would be by far not sufficient. There is a risk that employed dentists are entering into conflict with their employer and face pressure, if they claim to comply with the requirements of professional law. In addition, a frequent change of personnel in the dental chains can be observed, which makes constant monitoring from a professional law perspective difficult. Where no dental chambers exist, an equivalent level of control of professional law must be ensured either by the national authorities or by dental associations, which are representative for the profession.

The nationwide campaign in North Macedonia will launch on March 20<sup>th</sup>, 2020 with a press-conference where all the details of the campaign will be revealed to the media and the interested groups. The media will have the chance to learn which 9 cities around the country will take part in the campaign that will have its own branded caravan with a team of people that will visit those 9 cities and the main event will be held in the capitol of the country, Skopje, in the Central City

The caravan will travel with a host, animator, musicians and local dentists. The campaign will be followed by side events that will be individually organized by dentists in smaller towns. They will create their own goals like free check-ups, full dental treatment for under-priviliged and marginalized children, educational activities in the big companies for their employees, TV-shows and radio-talks around the country, and bulletins in national magazines
