in the association and its organisation

The non-governmental organization "Ukrainian Dental Association" was founded on October 23, 1994, and is the succession of the Scientific Society of Dentists of Ukraine. The association includes dentists, dental doctors, dental technicians and unites all regions of Ukraine.

In 2019, the dental community celebrates the centenary of the formation of the Ukrainian Scientific Dental School.

In 2019, the dental community celebrates the 25th anniversary of the founding of the Ukrainian Dental Association.

Trends and developments:

in professional politics

The NGO "UDA" cooperates with the Ministry of Health to coordinate and regulate the professional activities of dental doctors in Ukraine and is a member of the Coordination Council on Stomatology of the Ministry of Health of Ukraine.

There are 25651 professional dentists worked in Ukraine (as of 01.01.2019). Dental care was provided by 17,540 general dentists and dentists with a therapeutic profile (68.38%). 1919 dental professionals (7.38%) provided assistance to children and adolescents. There were surgical interventions on the maxillofacial area, 2113 dental surgeons (8.24%). Restoration of the integrity of the dentition, denture was performed by 3331 orthopedic dentists (12.98%) and 748 orthodontic dentists (2.92%).

17572 (68,5%) dental professionals of all specialties were employed in municipal and state healthcare institutions of the Ministry of Health system and other departments. 8079 (31,5%) dental practitioners were employed by private health care sector.

The number of dentists working in Ukraine per 10,000 population units was 6.1.



Each year, the Ukrainian Dental Association analyzes dental care in Ukraine and publishes a report.

in health and social politics

Recently, funding for dental care has been reduced by the state. However, no medical insurance was introduced.

The problems of providing dental care at primary level, ensuring the state guaranteed level of provision of dental care to privileged categories of the population and organizing assistance to the rural population are discussed at round tables in the Verkhovna Rada of Ukraine with deputies, experts of the Ministry of Health of Ukraine.

The Ukrainian Dental Association has requested the maintain of dental treatments for social security groups: children, elderly people and people at risk of social exclusion, disabled people, pregnant women.

in educational politics

13 Faculties of Dentistry in the University of the Ministry of Health, 2 Faculties of Dentistry in the University of the Ministry of Education and Science, 6 – private university provide training for dentists in Ukraine.

3 academies of postgraduate education of the Ministry of Health (Kyiv, Kharkiv, Zaporizhzhia) and 1 Ukrainian military medical academy provide postgraduate education and continuous professional development.

In 2019, there were 1583 students completed internship training, successfully passed the exam and were admitted to dental practice.

Continuous professional development of dentists is carried out by a scientific - teaching team of specialists, scientific and pedagogical workers of the dental faculties of medical universities of Ukraine, which unites the NGO "UDA". Significant is the holding of five (2012, 2013, 2015, 2017, 2019) National Ukrainian Dental Congresses with international participation. During 2018 - 2019 the Association cooperates with the European Academy of Continuing Medical Education and Professional Development.

Publishing activity. The NGO "UDA" coordinates and publishes scientific and practical professional journals «Modern Dentistry», «Herald of Dentistry», international scientific and practical journal «Dentistry. Aesthetics. Innovations», «DentaClub».
