## 29th/30th April 2016 in Baku.

Enclosed please find the **delegation form**, which I ask you to return to the ERO-secretariat not later than **February 28**<sup>th</sup>, **2016**.

The agenda for the meeting in Baku will follow as soon as possible. I inform you that in Baku there will be **elections for the ERO Board**. Available positions are president-elect, secretary general, two board members, (re-) election of the auditor. All person interested in a position in the ERO board are kindly requested to submit the enclosed form, a letter of support from the national association, a letter of intent and a personal CV. **The deadline for submitting candidacies ends on March 13<sup>th</sup>, 2016**. It has to be stated clearly what position in the Board the candidate is applying for. Candidates for the position of a Board member should in addition indicate if they apply for the position of a Treasurer (the Treasurer is one of the Board Members).

Please note that **no "last minute"-candidacies will be accepted**. All documents regarding candidacies shall be published on the website.

As in the past, working group meetings are going to be held in Baku on Friday, 29<sup>th</sup> April 2016, 10.00 - 12.00h. Please keep in mind art. 4 of the "Rules of procedure of the Working Groups of ERO-FDI". The Board meeting will be on Friday, 29<sup>th</sup> April 2016, 08.00 - 10.00h.

As always prior to our meetings, we ask you to forward to us your **national report**, which will enable us to have an overview on the professional and health political developments in the different member countries with the aim to identify the general trends in dentistry in Europe. Please let the ERO-secretariat have your report by e-mail until the **March 13, 2016**. To facilitate your and our work please see the enclosed "guidelines national reports".

As in the past, we will also include any report from a Working group or our affiliate member in our next mailing, provided that we receive it in time, i.e. <u>before **March 13, 2063**</u>.
