During the Plenary Session in Bangkok the ERO working group "Liberal Dental Practice" worked out and presented a statement under the headline "Liberal Dental practice in partnerships, practice networks and medical care units". This statement (www.erodental.org) was adopted unanimously by the plenary session in Bangkok.

Under the realization, that working conditions in cooperation and depending employment will rise in future and a tendency of institutional care includes the hazard to become more and more commercial, the ERO

WG "Liberal Dental Practice" decided to observe and discuss permanently the development of new forms of dental practice. So we tried in our last meeting in Basel to design a frame in which liberal practice should be established in the future. As defender of the principles of liberal dental practice we cannot introduce restrictive measures. We have to accept the evolution of trends in our profession but we have to defend and point out several particular aspects:

- We have to figure out the difference between "Collaborative Dentistry" provided by a team of
 professionals in various relations and "Merchants Investors" as owners of dental clinics whose sole
 purpose is the profit;
- To prevent pure commercial activities in dental healthcare, legislation has to be equal for all actors in healthcare;
- Therefore dental associations are necessary and dental practices have to be member of the same body to safeguard the same working conditions;
- "Liberal Practice" has to be explained to dental students and colleagues;
- It is under the responsibility of ERO and other dental associations to inform the local dental
 associations and state authorities about the danger in the change of offering dental services and
 their supposed business advantages.

In cooperation with Marco Mazevet, past president of the European Dental Students' Association, it can be realized to publicize the basics of Liberal Dental Practice in the social networks of EDSA. Additionally it is planned to install a task force "Liberal Dental Practice" in the EDSA to transfer the aims of this important theme to the European Students.
