Letter of Intent for ERO Election

Candidate: Dr Edoardo Cavallè, ANDI (Italy) Position: President-Elect



Esteemed Colleagues of the Plenary Session, Dear Friends,

As you know already, my name is Edoardo Cavallè. I graduated in 1985, obtaining a Dentistry degree from the Statale University of Milan, where I specialized in Orthodontics. Since then, I have continued my practice within the NHS and as a practice owner in Monza (Milan). In 2002, I obtained the Certificate of Management as Director of Public National Health Service.

For the last three years, I have had the honour of being a Board Member of ERO; this was just the last of my positions after a long journey together. I have been participating in ERO activities since 1989 when I attended my first Plenary Session as a delegate for Italy in Rome: this means that I have been active in ERO for more than half of my life. In this time, I have been chairman of the WG Dental Team and a member of many others; head of the first team that created the ERO website; liaison of FDI Council for three mandates and, for five years, member of FDI Finance Committee.

Moreover, I have the pleasure to serve in other international institutions concerned with dental medicine and oral health. In FDI, I served for two consecutive terms as a Council Member. I have been a member of the WHO Collaborating Centre for Developing Countries in Rome since 2004. Besides, I have been CED Vice-President in the year 2000; since then, I have shared the Council's activities participating and chairing numerous working groups, most recently Dental Material and Medical Devices and, as a member, Education and Professional Qualifications.

Today, I come to you as a candidate for the position of President-Elect.

If elected, I will put all my efforts into supporting and furthering the decisions of the ERO Board while increasing the capabilities of networking with all member associations. It was an honour and privilege to serve on this Board led by dr Frank, and I hope you allow me to continue with dr Dianiskova. ERO has been a keystone for European dentistry, a place of dialogue and mutual understanding, held together by one principle: the need to promote the scope of oral health, intended as a fundamental right and the main component of our patient's well-being. At present, 37 countries share whit us this vision,

recognizing ERO as their home. It will be my privilege to make sure that this trust is not misplaced, increasing the integration in the mutual respect of historical backgrounds of dental education, moving together towards the future challenges of professional practice.

I will also strive, together with my colleagues, to ensure all our members' capability to access ERO initiatives, working groups and activities: in particular, ERO has to increase more his impact on FDI. All ERO Member Associations were deeply impacted by COVID-19: most of us are still struggling to solve the contingencies that the past two years imposed on our profession. The return to normality that was prospected after the end of the pandemic is being timid at best; in many countries, a consistent percentage of patients are still deserting our cabinets, worried by economic fluctuations and social uncertainties. It is now patent, therefore, how normality is not a fact to recuperate looking at our past, but a value to create imagining our future. As a President-Elect, it will be my duty to do to all that is in my power to help ERO being one of the paramount voices guiding this process.

Our numbers and determination confirm that these objectives are fully within our reach. After this long pandemic winter, ERO will be ready to meet all the challenges ahead and support all those in need. In conclusion, my job will be to help the association reach its ultimate goal, the defence and promotion of optimal oral health, holding ERO principles in mind together with my personal motto: Let's go together to go far away.

Together means that no one can be left behind. Therefore, we can not ignore the tragic and dramatic news coming from Ukraine that obliges us to find a common plan to help our Ukrain Colleagues and the refugees.

I will do everything is in my capabilities to uphold the task and serve as ERO President-Elect: truthfully, honourably and efficiently. I wish to thank ANDI, my association, for the support and encouragement shown to me up to this point.
