Changes

Number of members is increasing - 1094, vs 1071 in 2019

Trends and developments:

in professional politics

- A questionnaire was sent to the members of EDA looking into their needs in professional life. Most of the members expressed their wish to get legal advice
- A meeting with the Head of the Radiation Department of the Environmental Board on radiation licensing took place to reduce bureaucracy for dental clinics
- Critical evaluation of marketing in dentistry

in health and social politics

- EDA had a leading role in reorganising dental treatment during COVID-19 breakout in Estonia by:
 - Proposing Health Board of Estonia to stop regular treatment of patients until the clinics were provided with personal protective equipment
 - Developing specific guidelines on how to provide first aid and emergency care to patients in the circumstances of COVID-19 breakout in March and April 2020
 - Procuring personal protective equipment for the members
 - Proposing possibility of e-consultation in orthodontics and dentistry
 - Fast vaccination of all dentists and dental staff in clinics in cooperation with Health Insurance and Health Board
- Meeting with the Ministry of Social Affairs on the topic of process and conditions for registration of dentists from third countries as health care professionals. Justification and possibility of clarifying the language requirements for health care professionals and entry in the register of dentists in Estonia
- Meeting in the the National Audit Office on the topic of adult dental care benefit audit

in educational politics

- Discussion about vocational training of dental assistants with the staff of Tallinn Health Care College.
- Oral health knowledge is improved by a series of courses for teachers and parents, also in ICT environment: www.suukool.ee

Corporate Dentistry

- position of NDA towards dental chains:
 We have one big chain of dental clinics, consisting of 11 dental clinics located in different parts of Estonia "Unimed's United Clinics". Ownership is investments
 Funds Based on the experience of other member countries we are concerned about the future trends.
- problems with dental chains currently most of the dentists do not complain openly but changes in the daily working of dentists are noticed continuously
- possible solutions to limit chairmanship in corporation (51% dentists)?

Changes in fees:

Fees for dental care have been free in Estonia since 1991, as we have 100% private dentistry. New fees were fixed for dental treatment procedures by Health Insurance Foundation in 2018, but not accepted by half of the dentists. Cost-effective fees for direct dental restorations are currently being recalculated in cooperation by EDA and Health Insurance Fund of Estonia

Information regarding promotion of the World Oral Health Day:

As part of Oral Health Day, we publish all-Estonian articles and posters and run a kick-off campaign: we collect smiles and inform about the connection of oral health with general health.

In 2020 Estonian team won the award of FDI for the "Most Educational Activity" during the World Oral Health Day, in particular for releasing Suukool's toothbrushing song in three languages and all the media work. https://www.youtube.com/watch?v=Zl1Uqg0rpcg

- Two council meetings and 25 board meetings were held
- Two conferences were held (06.03 and 04.12.2020)
