### About FDI


FDI serves as the principal representative body for over **one million dentists worldwide**. Its membership includes some 200 national dental associations and specialist groups from more than 130 countries.



- Detail FDI's position on issues of interest within the oral health community
- Compiled through close consultation, discussion and consensus among an international set of experts & approved by FDI members
- Develop policies, strengthen standards and share information related to all aspects of oral healthcare
- Address issues of both public and professional concern and are sensitive to varying approaches to dental care around the world
- Example topics: Providing Basic Oral Healthcare for Displaced Persons


