It has to be stated clearly what position in the Board the candidate is applying for. Candidates for the position of a Board member should in addition indicate if they apply for the position of a Treasurer (the Treasurer is one of the Board Members).

Please note that **no "last minute"-candidacies will be accepted**. All documents regarding candidacies shall be published on the website.

As in the past, working group meetings are going to be held in Frankfurt on Friday, 26th April 2017, 08.00 - 12.00h. Please keep in mind art. 4 of the "Rules of procedure of the Working Groups of ERO-FDI". The Board meeting will be on Thursday, 25th April 2019, 15.30h.

As always prior to our meetings, we ask you to forward to us your **national report**, which will enable us to have an overview on the professional and health political developments in the different member countries with the aim to identify the general trends in dentistry in Europe. Please see the letter of the General Secretary, which is enclosed. Deadline for submitting the national report is **March 8th, 2019**. To facilitate your and our work please see the use the enclosed "national reports template".

As in the past, we will also include any report from a Working group or our affiliate members in our next mailing, if we receive it in time, i.e. **before March 8th, 2019**.
