Target of this WG-meeting is to clearly define the position of Dental Hygienist in Europe in relation to the subjects and duration of their training (School and Practise), responsibilities, continuing education courses and employment/assignment in a Dental Practise.

#### DENTAL HYGIENIST

#### DENTAL HYGIENIST Consideration 1

The analysis of the situation shows that a DH and other oral similar dental professionals are strongly supported by politics for economical reasons.


