- **Results of ERO WG Integration activities starting 2011:**
- **Sofia 2011** – was changed the name of the WG from Enlargement to Integration. New members of the WG.

- **June 2011, Moscow** - preparing for the creation of Eastern European dental association for more effective work with ERO due to the same educational, practical, cultural relations and using Russian language for all Eastern European countries.
- **Mexico 2011** - establish a good relations between ERO countries, importance of relations with Ministries of healthcare of national countries, have feed-back from Eastern European countries, by exchange between ERO Western, Central and Eastern countries we can solve dental professional problems improving items of prevention, dental education, liberal dental practice, quality and standards of oral healthcare.

- ***November 2012, Moscow*** — meeting of the Presidents of Eastern European dental associations and ERO WG Integration members dedicated ERO collaboration, dental professional education in ERO countries and suggested program of prophylaxis.

The agenda of ERO WG Integration meeting in Moscow was dedicated to modern aspects of the work of the National Dental Association, structure, duties and policy success of the National Dental Association, dental practices and quality control services provided by the NDAs, insurance systems in ERO countries. The WG members prepared ***first Resolution from the ERO WG Integration*** to the National Ministries of health which is currently adopting and will suggest to ERO Board and Plenary Session in Potsdam.

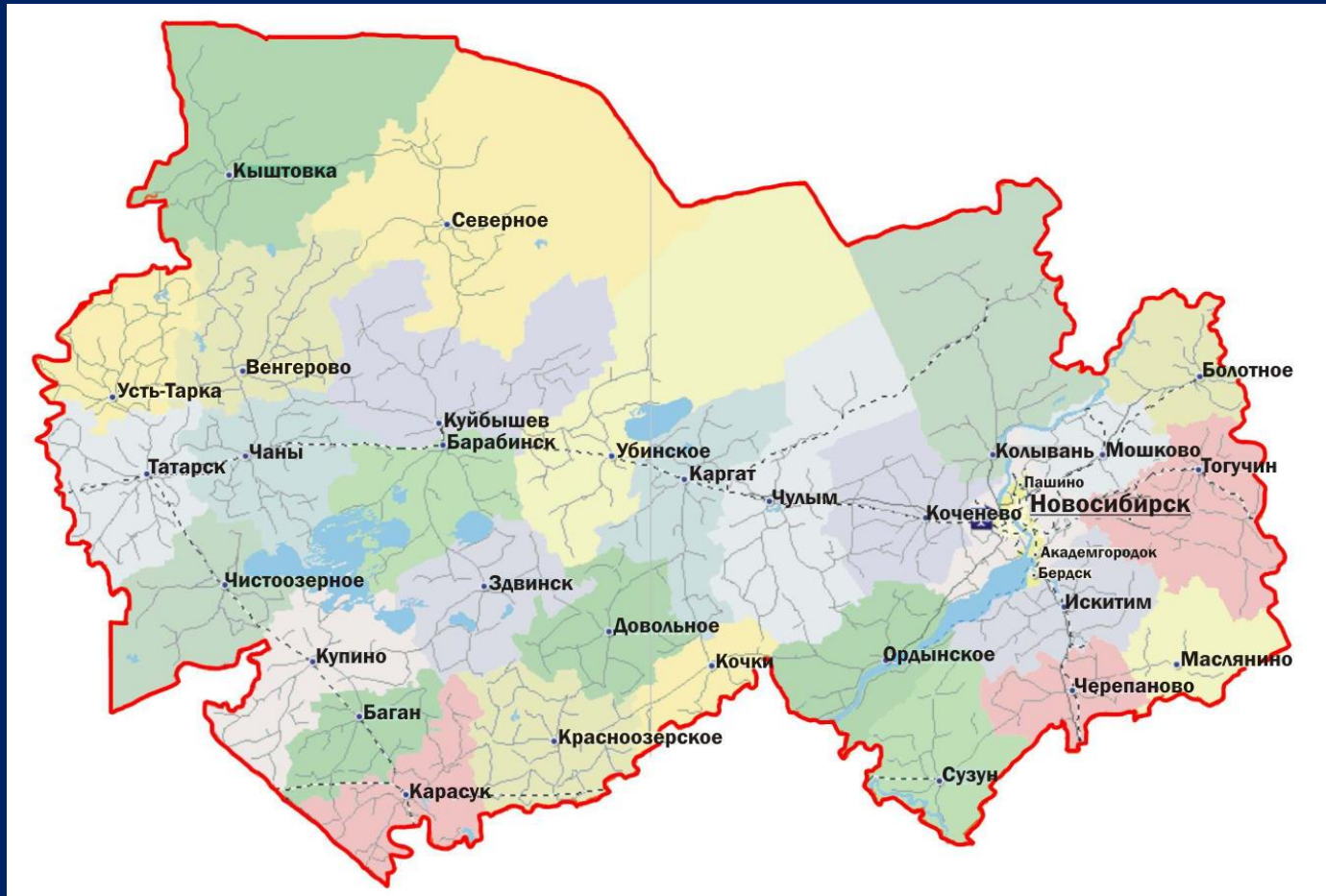
