New provisions regarding invoices and fiscal receipts

Law no. 228 of 24 December 2012 has adopted the provisions on invoicing contained in Directive 13 July 2010, 2010/45/EU of the European Council. Article 21 of DPR633/1972 is modified in order to make required additional elements that the bill should contain. The previous version provided that the invoice should be dated and numbered sequentially per calendar year. The new formulation provides that the invoice must contain "the serial number that uniquely identifies it." Resolution 1/E of 10 January 2013 of the Revenue Agency clarifies, as from 1 January 2013, how the unique serial number and can be achieved.

Clinical Guidelines from the Ministry of Health

The Ministry of Health has recently published two important documents that integrate the guidelines and specifications already published on the topic of dentistry. The document "Drug-addict population: indications for oral health promotion and interventions of prevention and protection. According to the Ministry, the aim of the document is to provide guidance to promote oral health, prevent oral diseases in drug addicts and prevent the occurrence of occupational infections.

In the month of December "National Guidelines for the prevention and clinical management of dental trauma in individuals in childhood" were published. These guidelines are particularly relevant in view of the need to disclose the recommendations on the prevention, diagnosis and treatment of dental trauma that is one of the most common dental emergencies in children. The objective of this document is to provide clear guidance, shared and based on the best available scientific

Dentist/patent ratio. A survey.

In 1990, registered dentists were 18,144. Twenty-two years later (November 2012) registered dentist are 58,203, an average of about 2000 members more each year. The ANDI Research Department has analyzed the 2012 data of the various Italian regions and comparing with the current number of population in Italy (60,626,442), thus identifying the dentist / patient ratio. The number of potential patients per Italian dentist is 1042, provided that all Italians go to the dentist. The region with the greatest potential number of patients per dentist is the Valle d'Aosta (1,623) followed by Basilicata (1,406), and Sicily (1271). The regions with the worst the dentist / patient ratio are Liguria (767 people per dentist), Friuli Venezia Giulia (803) and Marche (851). The data show how far is the optimal ratio indicated by the WHO. For decades the dental plethora has been and still is a problem also because it increases the basin of the number of young dentists who fail to exercise in a studio. A recent survey we made, indicated that a new graduate takes an average of 6-10 years to open its own practice. It is a twofold problem: open a studio today is very expensive even in bureaucratic terms, and there are no patients in sufficient numbers to support the initiative.

Project "5 minutes to save a life"

"5 minutes to save a life" is a project of continuing education, combining the efforts of the ANDI Foundation and ANDI on the primary and secondary prevention of oral cancer. It's an ambitious project aiming to best represent the "best practices" and culture of prevention proper of ANDI.

The project "5 minutes to save a life", aims to updating the basic knowledge in terms of primary and secondary prevention of oral cancer, a disease with increasing epidemiological incidence, characterized by a dizzying and everadvancing scientific knowledge and by the awareness that dentists, are the only practical means of prevention for this disease, because of their network distribution in the territory.

"5 minutes to save a life", it is also a social project: an awareness campaign called "We need to talk about it," is aimed to represent to the entire Italian population the direct link between some habits and lifestyle behaviors, in each age group, such as smoking, unprotected oral sex, some professional activities and the increasing spread of cancerous lesions in the mouth.

Project ANDI Young

ANDI will develop a range of services aimed at encouraging young dentists to enter into the world of work. The project "ANDI Young" aims to satisfy the needs of students and young dentists, as well as to support members ANDI "under 35", providing a platform of dedicated services that will enable the young fellow to grow as a dentist but also as a professional. Briefly: to contribute to post-graduate training of young dentists; provide fiscal instruments to facilitate their entry into work; create a community in a reserved web area, provide information about the performance of the dental industry. The project ANDI Young will start to be operational in the current year.

A TV spot against Illegal practice

After many articles and magazine pages, billboards and leaflets, all funded by ANDI to warn people against fake dentists, the Association's aim is now to utilize the television to talk to people. With this goal, ANDI and ANDI Onlus Foundation and the Civic School of Film and Television in Milan have created a contest for young talents in order to create a innovative spot to combat illegal dentistry. Indeed many students and former alumni of the School have independently proposed original screenplays: some of these were chosen by a jury composed of representatives of the various project partners and members of the media and television. The videos were presented for the first time in an event organized by ANDI on Jan. 31 in Milan and the spot that will be used to campaign against illegal dental practice and broadcast by major national television networks will be chosen among the three winning videos.

Oral health and prevention for the prison's inmates

The first of a series of meetings aimed at raising prison's inmates awareness on the theme of health and prevention of oral diseases was held on February 19 in the prison of Asti (Piedmont).

Sponsored by the ANDI Foundation in collaboration with the Association's departments of Asti and Piedmont and with the Regional prison's Superintendent for the Piedmont and Valle d'Aosta regions, the event saw the participation of 50 inmates to whom the volunteer doctors have explained the most common oral diseases and the associated risks and the importance of good oral hygiene. Inmates were also distributed brochures and kits consisting of toothpaste and toothbrush. As we all know the correct hygiene of the mouth and teeth through the use of regular toothbrush and toothpaste are essential to prevent the many diseases that can affect the mouth, but in reality such as the prison, where the forced cohabitation makes common bad habits and

promiscuity using the tools of hygiene, the risk of transmission of viruses and bacteria is particularly acute. For this, ANDI Foundation has chosen to intervene in Italian prisons with the "Oral Health in the Penitentiary Institutes" which is currently active in Rome, Sicily and Piedmont thanks to the ANDI members who support their Foundation as volunteers.

University 'Pessoa'

On March 13th, the Regional Administrative Court of Lazio rejected the appeal proposed by the Portuguese University "Pessoa" against the revocation to the authorization to open a subsidiary in Italy. In this circumstance, ANDI had renewed the assignment to its Legal Department to oppose the reasons of Pessoa University, which intended to open in Italy a Course in Dentistry, with 250 students enrolled. This fact would have meant the annihilation of the system of planned access to universities, greatly increasing the professional plethora, without giving any guarantee on the quality of the provided training. Once again ANDI was alongside the students, the Italian University, the Ministries of University, of Foreign Affairs and of Interior and FNOMCeO, achieving this further, significant victory.
