Intent Letter

I am a 1992 graduate of the Faculty of Dentistry at the Medical University in Gdańsk, Poland. In 2000 I obtained the qualification of a specialist in the field of periodontology. I am an active dental practitioner (currently running an individual specialist dental practice in Olsztyn) since 1992.

Since the beginning of my professional work I am actively engaged in the activities of the dental organizations in Poland (especially in the professional self-government of physicians and dentists – Polish Chamber of Physicians and Dentists which consists of 24 regional chambers and the Supreme Chamber) as well as on the international level (FDI, ERO-FDI, CED).

Within the Polish Chamber I held the position of Secretary of the Regional Medical Council in Olsztyn for two terms. Currently I am the Vice President of this Regional Council as well as the Vice President of the Supreme Council – now in my second term.

Throughout these years I have obtained wide experience in preparing and coordinating the activities of a large professional organization.

For the last 3 years I have based on this expertise and experience holding the position of the ERO-FDI Secretary General. Beside conducting and supervising the everyday functioning of our organization I have actively participated in elaborating some important documents, including internal ERO-FDI regulations (e.g. Rules of procedure of the Working Groups of ERO-FDI; amendments to the Constitution) as well as position papers (e.g. Statement on the role of dental technicians).

The experience gathered throughout the last 3 years and the positive assessment of my activities expressed by many Colleagues have encouraged me to continue the work within the ERO-FDI and to submit my candidacy for the position of the ERO-FDI President-Elect. I am grateful to my national organization for supporting my candidature.

I consider the ERO-FDI a very important organization that associates dentists from all over Europe. I still think that one of the most important issues is the co-operation between dentists from the EU Member States and from the non-EU European countries.

My main goals as the ERO-FDI President-Elect and subsequently President include in:

- to strengthen the perception of ERO-FDI as a visible, significant dental organization that represents the profession within the whole European region;
- to make sure that all the issues important for our profession are properly handled within the ERO-FDI;
- to develop the role of ERO-FDI within the structures of FDI;
- to encourage and support the works of ERO-FDI Working Groups as the vital day-to-day element of the organizations activities;
- to follow-up on the current working model of the ERO-FDI, while further developing and expanding the administrative functioning of the organization to make it as efficient as possible.

The following issues are, in my opinion, the key fields of ERO-FDI's activities:

- safeguarding the role of the dentist as a liberal professional, leading the dental team;
- defending the ethical principles of our profession, most notably the professional independence;
- emphasising the medical rather that the technical nature of the dental profession;
- raising awareness of oral care and its significance to overall health among the society and the authorities;
- development and promotion of under- and postgraduate dental education.

This list is, of course, not exhaustive and many other issues (including all the matters dealt with by the ERO-FDI Working Groups) are of importance and need to be given proper attention.

I am convinced that my experience and expertise remains useful for the activities of the ERO-FDI and I hope that I will be given the opportunity to further serve the interests of our profession, contributing to the achievement of the ERO-FDI objectives.
