

## The report of ERO WG Integration meeting

15<sup>th</sup> of November 2012 in Moscow to ERO FDI Board

The President of FDI Orlando Monteiro da Silva and the main dentist of the Ministry of Healthcare of Russian Federation and Rector of Moscow State University of Medicine and Dentistry Professor Oleg Yanushevich attended ERO Working group Integration meeting in Moscow.

Their support to integration in ERO shows the importance of this issue according world globalization and harmonization.

The agenda for the first meeting of ERO WG Integration in Moscow was dedicated to **modern aspects of the work of the National Dental Association**, structure, duties and policy success of the National Dental Association, dental practices and quality control services provided by the NDAs, insurance systems in ERO countries. Michele Aerden, Jurgen Fedderwitz, Edoardo Cavalle have reported on this items.

The second issue was the **National Program of dental diseases prevention as a basis of national dental associations work**. Collaboration with the dental professionals and Minister of Health is key. The third issue for discussion was **continuing education**. The role of NDA in the development and control of continuing education and the accounting system points of NDA were explained by the speakers.

Following the **open discussion** amongst the participants, it appears that the main problem for the NDA is to be recognized by their Ministries as the representative of the dental profession. It is impossible to collaborate on prevention and continuing education programs without a good collaboration between the Minister of Health and dental professionals.

The WG prepared a resolution to the National Ministries of health. This resolution was adopted unanimously by the participants at the end of the meeting.

Afterwards, the resolution was translated in Russian and sent in English and Russian by mail to each participant for comments. Again the agreement from all participants was received.

The WG Integration wants to submit this resolution to ERO Board for presentation and adoption in the Plenary Session in Potsdam.

It would be a tool to start dialogue with the authorities.

Next step for the WG Integration would be to address the issue of a strategy for prevention in oral health in the country.
