Trends and developments:

in professional politics

Membership is increasing (956 = 71% of dentists) We had two-days brain-storming about the development directions and needs for Estonian dentistry

in health and social politics

Our president dr. Marek Vink was titled as one of the most influential figures in Estonian health politics in 2017

New arrangements for financial compensation for dental treatment for Estonian adult population by the Estonian Health Insurance Fund have been introduced

in educational politics

A curriculum for dental assistants is being prepared by the Tallinn Medical High School to educate dental assistants with no medical education (currently trained locally in dental clinics). The course will be open for registration in October 2018



in the insurance system (incl. the public health insurance and private insurance schemes)

New fees were fixed for dental treatment by Health Insurance Fund 01.07.2018

New compensation system for dental treatment for adults was introduced. Refunding for the treatment cost is possible only in case of existing contract between the dental clinic and Health Insurance Fund. Less than half of practicing dentists have signed this contract, because of complicated accounting and time consuming reporting. Also the fees for treatment are in most cases not costrelated. It means that compensation for treatment is not available for major part of citizens, as it can be applied only in case of service with fixed by Health Insurance Fund fees.

in dental care for persons applying for asylum or refugees The refugees are provided with medical insurance as persons living in Estonia by virtue of a temporary residence permit or by the right of permanent residence i.e. when the refugees have been officially registered they are on the same terms with Estonian citizens concerning dental emergences and treatment.

of dentists: problems and possible solutions

Close to 25% of registered dentists work abroad. Therefore access to dental treatment is growing worse. Dental clinics are concentrated in the cities. Very few clinics stay open in rural areas.

of persons applying for asylum or refugees: problems and solutions in dental care.

For the unemployed people access to dental treatment is poor due to financial reasons. It is similar for refugees and local people, as there is no community dentistry in Estonia

Changes in fees:



New fees were fixed for dental treatment procedures by Health Insurance Fund 01.07.2018, but not accepted by the majority of dentists. Fees for dental care have been free in Estonia since 1991, as we have 100% private dentistry.

Information regarding promotion of the World Oral Health Day:

Concerning oral health, we have a running project "Oral Health School" financed by the Estonian Health Insurance Fund and carried out by dentists. 280 lectures to101 20l children, and 2940 parents and caretakers have been delivered during the year 2017. 80 000 printed items (workbooks, calendars, newsletters) about oral health have been distributed for the schools and kindergartens, both in Estonian and Russian languages. 10 000 toothbrushes have been delivered to boarding schools, and families with limited resources.

World Oral Health day in Estonia will be celebrated as follows: -During full month there are many lectures about oral health in schools and in the museums, frequently visited by children.

- -Using social media, questionnaires about oral health are presented. Participation is motivated by an award.
- -On 20th of March Estonian broadcasting companies are employed to deliver oral health messages to the population

- A book for children with oral health messages will be introduced also on 20th of March
