Changes

in the association and its organisation New President of KSA became Dr.Aslan Zhangereyev in October 2017. At the same time new President Elect was elected, his name is Galym Pernebayev

Trends and developments:

- 1. In professional politics: The state increased the amount of free guaranteed dental care for children and pregnant women. KSA cooperates with Health Ministry and National Chamber of Health Care for more fruitful solving the problems of dentists in Kazakhstan and for organizing dental Congresses and Conferences, using the experience of European dentistry.
- 2. In health and social politics: Kazakhstan has adopted the Strategic Plan of the Ministry of Health of the Republic of Kazakhstan, aimed at the formation of a healthy competitive nation, the improvement of the dental service system and the development of Kazakhstan dentistry
- 3. in educational politics: It is required to establish the correspondence between the requirements of such documents as the "State compulsory standard of education of the Republic of Kazakhstan" and the "Profile and competence of the European dentist". Acquaintance with the activities of the European Association of Dental Education, the establishment of direct business contacts, the further development of integration, promoting dialogue and cooperation among educators in the



- European countries; presentation of international trends that promote high standards in the development of dental education.
- 4. in the insurance system (incl. the public health insurance and private insurance schemes): The system of compulsory health insurance in Kazakhstan will be implemented in stages from 2017 to 2024. Also, the percentage of mandatory contributions will increase in stages. The basic package is the guaranteed amount of free medical care. It includes ambulance, sanitary aviation, assistance with diseases of social significance, and routine vaccination. Financing is The basic package is the guaranteed amount of free medical care (GFMP). It is now and includes ambulance, sanitary aviation, assistance with diseases of social significance, and routine vaccination. Financing is at the expense of the republican budget. The second package includes outpatient and inpatient care, rehabilitation, palliative care and nursing care, and high-tech care. Financing is from the Health Insurance Fund, where the population will transfer contributions. The third package is individual - in the event that a citizen wants to receive an extended list of medical services, he will need to make deductions in excess of the approved percentage. From the payment of contributions to the Social Health Insurance Fund will be released: children, mothers with many children, participants and invalids of the Second World War, pensioners, invalids, officially registered unemployed (registered in employment centers), boarding students, full-time students of technical schools, trade schools, universities and postgraduate education in the form of residency, mother on maternity leave in connection with the birth of a child (adoption) of a newborn child) and to care for a child before reaching the age of 3 years, the military, employees of special government and law enforcement agencies
- 5. in dental care for persons applying for asylum or refugees: medical care in accordance with the legislation of the Republic of Kazakhstan in the field of health;

Changes in fees: Number of members of KSA decreased from 2000 to 1000 because half of dentists became members of UKAD. So we consider that our fees also should be decreased
