Turkish Dental Association (TDA) selects its delegates who ensure the formation of TDA with its General Assembly. Our law relating to the distribution of the delegates according to the Chambers was annulled by the Constitutional Court. Therefore our Chambers could not make the election of their delegates in their General Assemblies realized in April 2014 and TDA could not organize its General Assembly which was planned to be taken place in October 2014. From all reasons above, our current Board of Directors whose term of office is two years will continue to serve until the period determined by the new law.

#### II. Trends and developments

- In professional politics
  - Employment of dentists in public

#### Personnel Rights of Dentists and Public's Receiving Services from Clinics

State- owned Social Security Institution (SSI) of Turkey which only purchases the health care services regarded the offer of Turkish Dental Association significant on prioritizing the preventive applications and SSI presented this offer to the Economic Coordination Committee which directs the country's economy. The Committee, showing the economic conditions in our country as a reason, stated that public should not get services from the private dental clinics for now.

When it comes to the issue why the public should get service from private dentists, our Association is about to end a project of 20-year projection to demonstrate its claim a scientific analysis that our offer containing protective applications will affect the public finance in in a positive way the long run.

The Ministry of Health tried to continue to increase the employment of dentists in public sector also in this year. It has been trying to equalize the numbers of the self-employed dentists and dentists working in public sector.

The Ministry of Health encourages not the qualified treatment but the care for more patients in number is encouraged by the practice based on performance.

#### • Preventive Practices for Public Oral Health Care

Oral and Dental Health Action planning works 2013-2018 of Ministry of Health which aims to reach all school children was started in cooperation with our Association in 2013.

This Action Plan would be a an important and comprehensive application for the public finance by providing savings in terms of prioritizing the protective applications in oral health as well as having a dental problem-free generation by tracking the oral and dental health problems in children for a long time. But on the change of the Minister of Health, this project failed in the same year.

## • Regulation on Healthcare Organizations Providing Oral and Dental Healthcare Services

The Ministry of Health of the Republic of Turkey promulgated the *Regulation on Healthcare Organizations Providing Oral and Dental Healthcare Services* with the date of 02.03.2015 and the number of 29256 despite all the objections and actions of the Turkish Dental Association.

With a number of changes made by the Ministry of Health in the *Regulation on Healthcare Organizations Providing Oral and Dental Healthcare Services* which regulates working conditions and requirements of the dentists, it was created a field to non-occupational capital and these changes will have many negative consequences against dentists and patients in the future.

The decisions taken with the said regulation will bring the dentists in a workmanlike position besides capital owners and dentists will no longer be a self-governing professional

group. The regulation will prevent the development of the profession and will jeopardize the future of the profession. It will also cause unrecoverable destruction.

#### Health Figures

TDA rejected the request of the Ministry of Health of the Republic of Turkey to send in silico the data of the patients who have applied to our surgeries without the consent of the patients although there is no regulation regarding health data protection of the basis and procedures of the protection of health data in our country yet. Our Chambers and our colleagues stood out against this request despite the threat of criminal sanctions of the Ministry. The Ministry of Health had to take steps backward from its request.

#### - In educational politics

#### Continuing Dental Education

Turkish Dental Association Continuing Dental Education (CDE) aiming the post graduate education of our colleagues was disciplined by a directive regulation made in 1998.

In 2014, Continuing Dental Education (CDE) Directive has been renovated in a more comprehensive manner according to the changing needs. The new regulation highlighting accreditation provides that the competence development programs could be realized within the body of TDA and institutional and physical conditions were created more broadly described in the following article

#### • TDA Competency Development Project

The rapid development of dental profession in our country and around the world, the changing needs of society about the oral and dental health care and the need for professional continuing education have showed up more crucially than in the past decades.

Need for qualified human resources, reflections of fast-growing technology in dentistry, strengthening the service-quality oriented approaches and the demanding form quite a large market for professional training

There are many training activities organized in the field of dentistry. Contribution of each training activities to profession and colleague is not the same. The main principles of professional continuing education, application methods, and success criteria have been an important issue for many years studied by many professional institutions and universities around the world; they are generally accepted and their success has been determined.

The first information that is required to evaluate the success of any training given in any area is the educational gains that have been identified in various sizes. When it comes to professional continuing education, educational achievements have been revealed as the development of the capabilities that a dentist should have after the bachelor's degree.

For that purpose; in order to form a basis for the evaluation of continuing professional education programs by our Association, the structuring of the organization which includes the procedures for determination of Professional Qualifications and Standards is ongoing.

It has been requested contribution and co-operation from Ministry of Health for the implementation of the organization.

#### • Dental Faculties

In Turkey, by the year 2014, there are 62 Dental Faculties. Currently, there is education in 40 of these faculties.

In 2013, while the population of our country increased 1,37 %, the number of dental students increased 18,97%.

Due to the continuation of the opening of the new Dental Faculties without proper workforce planning, lack of the geographical distribution of the workforce and poor dental visits, our colleagues continue to face a serious unemployment problem.

#### - Some Other Information

#### • Solidarity Fund

In 2014, we have helped to our 3 dentists and their families from the Fund of Solidarity which aims to assist the dentists and their families who have great difficulty to practice their professions by reason of natural disasters or serious illnesses.

Turkish Dental Association subsidized to the Dental Association of Bosnia & Herzegovina "€2.500 (Two thousand five hundred Euros) because of the flood disaster in the country.

The income of the Fund is composed of the fees that our members pay to their Chambers.

#### • Incapacity Insurance and Personal Accident Insurance

It is arranged by Turkish Dental Association the Incapacity Insurance and Personal Accident Insurance for the members whose names are notified by Chambers of TDA. Due to

the Insurance, it is decided to pay approximately 7.500 USD for once only to the relatives of the dentists who has died or has been injured in an accident and unable to practice their profession. Also for the colleagues who has unable to practice their profession temporarily, Turkish Lira equivalent to USD 50 is paid for a period not to exceed 200 days in a year.

#### **III.Changes in Fees**

#### - Medical Fee in Private Dentistry

Examination and Treatment Wage Tariff in private practice is determined and put into effect by Turkish Dental Association through the right of legislation according to the cost analysis based on scientific data.

#### **IV. Further New Information**

#### - International Congresses of the Turkish Dental Association

The 21<sup>st</sup> International Congress of Turkish Dental Association will be held between May 28<sup>th</sup> and 30<sup>st</sup>, 2015 in Istanbul Congress Center, Istanbul. The congress preparations are being maintained at national and international level.

#### - Cooperation with Other Health Association

In the partnership with the solidarity between Health labour and professional organizations, TDA takes part in the studies predominantly consisting of cooperation and solidarity to be more effective against negative enforcement of the government for patient health and healthcare professionals.
