Results of the surveys

- qualifications of European dentists are on the same level (automatically recognized between the EU Member States)
- dental materials and working techniques used by the dentists are on a similar level in European countries
- differences occur when it comes to the evaluation of dentists' work and the prices and reimbursements for dental care
- movement of dentists and patients proves that the main differences that are observed relate to economic factors
- movement of dentists from the new EU Member States is not as huge as expected
- movement of patients ("dental tourism") is more visible patients search for dental care that is cheaper, but still of high quality

Rome 2009: the WG Parity had fulfilled its task and it was time to dissolve it.
